Greetings of the Day....

The Extra Ordinary General Body Meeting of Indian Desalination Association will be held on **28.02.2021 (Sunday) from 11 AM onwards (Online)**. The agenda points are as follows:

1. Welcome address by the President
2. **Election 2021:** The InDA election issue was deliberated in detail. Considering the current pandemic situation, the EC was of the opinion that the tenure of current EC members should be extended by one more term of two years (April 2021 to March 2023). Since, election involves all the members of InDA, the EC decided to call an extra ordinary general body meeting (EGBM) for the approval of this proposal by the InDA members.
3. **Establishment of InDA, North Zone at MNIT Jaipur:** The proposal of Head Chemical Engineering Department, MNIT Jaipur to start InDA North Zone Chapter at MNIT Jaipur, was discussed in EC and the same has been approved in principle by EC and as per InDA constitution requirement, it is being put up for approval of InDA GBM.
4. **Hiring of CA for InDA Audit Work for FY 2021-22:** The EC members were of the opinion that the hiring of CA firm for InDA audit work should be completed before the start of the financial year. Therefore, the EC proposed to extend the contract of the present CA (M/s. Manoj Manmal Jain & Co.) for the FY 2021-22 on the existing terms and conditions. It is put up for the approval of InDA GBM.
